



# Fire District secures land for station!


After nearly two years of searching and going through a partitioning process the Alfalfa Fire District completed a land transaction that will be home for the future fire station. The 2.72 acre parcel located just west of the COI canal along Alfalfa Market Road will be home to a planned 5600 square foot building and physical plant. Tentative plans call for construction starting in the spring of 2017 with a move-in date anticipated in the fall. **AED (Automated External Defibrillator)** Used by our firefighters and EMS responders in conjunction with CPR to shock cardiac patients.

## Burn Policy for AFD

- Check weather, <u>especially wind</u>, before lighting your fire.
- Do not burn prohibited materials (see list at right.)
- Keep piles small and manageable.
- Have fire tools (charged hose, shovel, and a bucket) at your burn site.
- Do NOT leave your burn unattended; must be attended by an adult.
- Extinguish your fire before leaving.
- If your fire escapes call **911**.

# Department of Environmental Quality Burn Material Restrictions

Burning the following materials is illegal anytime, anywhere in Oregon

- ✓ Asbestos
- ✓ Asphalt
- ✓ Auto parts (including frames)
- ✓ Dead animals
- ✓ Plastic and rubber products
- ✓ Tires
- ✓ Waste oil and petroleum products
- ✓ Wet garbage and food waste
- ✓ Any material creating dense smoke or noxious odors

With 2016 coming to a close we can look back with pride on our accomplishments. With the past 6 months we have become a functional fire district! While we will continue to improve our training and service to the community in the months and years to come we are off to a great start. A big "thank you" to the volunteers in the community who have stepped up to make this a reality.

We recently submitted a grant request through FEMA for Personal Protective Equipment (PPE) that will give our firefighters proper protection on structure fires and other hazardous calls. We are also part of a regional grant that is attempting to get updated communications equipment.

In addition, we are also submitting a grant request for a new water tender that is the major piece of apparatus still needed.

District residents are encouraged to visit the <u>alfalfafiredistrict.org</u> website to get more upto-date information than is available in our quarterly newsletter.

As a reminder, any calls for fire or medical assistance should go through **911** as our personnel are dispatched more efficiently using that method.

Deschutes County 911 is introducing a new feature of texting for 911 services in addition to calling. Become familiar with its features and when to properly use it.

#### **Fires During Holiday Season**

Recent information released by the Oregon State Fire Marshal's Office indicates most fires occurring during holiday season are caused by chimney (30%), cooking (13 %) with Christmas decorations, trees, and candles making up only 1 or 2% of the fires.

#### Helpful hints:

#### **Chimney Fires**

Clean and maintain your chimney or vent yearly, burn only seasoned wood, never use gas, kerosene, or charcoal light fluid to start your fire.

#### **Cooking Fires**

Bring cooking oils up to temperature slowly and never put frozen items into hot oil. Keep a lid handy to cover a pan should it accidently catch fire.

Never leave burning candles unattended!
